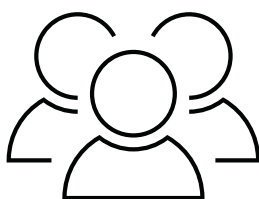

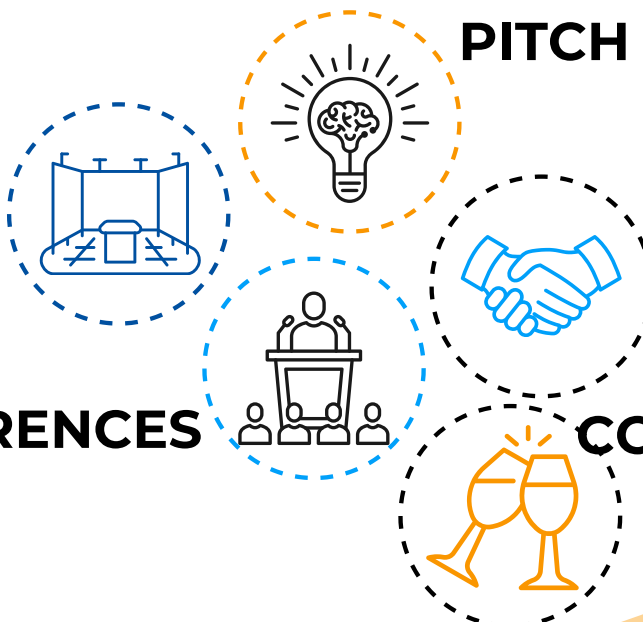

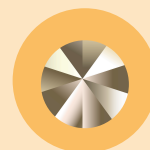

TERMS AND CONDITIONS OF SALE

PREAMBLE

The present General Terms and Conditions of Sale (hereinafter referred to as "GTC") apply, without restriction or reservation, to any partner wishing to acquire a proposed partnership. Offers of Products or Services are subject to availability. The Customer declares that he/she has read and accepted the present General Terms and Conditions.

SUBSCRIPTION

To become a partner and/or reserve an exhibition space, you must return one of the reservation forms [CRI] to the SKIN Summit secretariat, together with a payment of 50% of the amount due. The balance of the invoice is due no later than one week after the end of the event. No verbal reservations will be accepted. Booking and payment of the deposit constitute a firm commitment and oblige the subscriber to accept the general and special conditions of the partnership file.

LOCATION AND PLAN

Stands will be allocated on a first-come, first-served basis. After allocation, no change of location will be made without the written agreement of the organizers. We reserve the right to modify the size and layout of the surfaces reserved by the exhibitor, depending on the approvals issued by the venue.

CANCELLATION

All cancellations of stand reservations or other partnership options must be made by post to the Eurobiomed secretariat and will be subject to the cancellation conditions below:

More than 30 days before the event: 75% of the total net amount due non-refundable.

Less than 30 days before the event: no refund of sums due and paid.

MAJOR FORCES

In the event of force majeure, the dates of the event and the exhibition may be modified or cancelled altogether. In the latter case, the sums available after payment of the expenses incurred will be divided among the exhibitors in proportion to their payments, without any recourse being possible against the organizer or the director.

INSURANCE
